To make a claim under the Settlement, you must complete this form and submit it online or mail it to the address at the bottom of this form. Your Claim Form must be submitted online or postmarked by June 13, 2022, 11:59 p.m. Central Time. The information will not be disclosed to anyone other than the Court, the Settlement Administrator, and the Parties in this case, and will be used only for purposes of administering this Settlement (such as to audit and review a claim for completeness, truth, and accuracy).

You can submit a Claim for a Benefit under this Settlement if you purchased for non-commercial purposes a 600-watt or 900-watt model Nutribullet Blender, whether in-store or online, in the United States or any of its territories, between June 1, 2017 and March 15, 2022 .

**Settlement Class Members who seek payment from the Settlement must complete and return this Claim Form.** Completed Claim Forms must be mailed to the Settlement Administrator at Meister v.
